VISA SERVICE

IMPORTANT INFORMATION: The following information applies to Citizens and Nationals of ALL COUNTRIES, except citizens of the following countries: Botswana, Malawi, Mauritius, Swaziland, South Africa, Tanzania, Zambia, and Zimbabwe as they do not require an entry visa, when travelling to Mozambique for Tourism. However, if you are wishing to Work, Study or settling in Mozambique you are also required to apply for entry visa.

ALL APPLICANTS MUST SUBMIT THE FOLLOWING DOCUMENTS:

1. Passport valid for at least 6 (six) months, with a minimum of 2 (two) consecutive blank pages;
2. Visa Request Form Completed and SIGNED;
3. Photocopy of the first page of the Passport with a photo;
4. Two passport size photographs;
5. A copy of the return tickets to Mozambique or a copy of the flight and hotel confirmation from your travel agencies (this document must be detailed, signed and stamped by the travel agency);
6. Hotel/Hostel booking confirmation (official confirmation/receipt of payment);
7. Recent bank statement and travel insurance;
8. Details of travel information if you are entering Mozambique by car, bus or any other way;
9. Copy of your ID or utility bill if you are foreign Citizen living in France.

PLEASE NOTE:

- ✓ The Issuance of a Visa can take less or longer than usual;
- ✓ The payment of the Visa fee is not a guarantee that a Visa will be issued and the Visa Fee is not refundable.
- ✓ Travel/Emergency Documents can take between 5 (five) to 10 (ten) days to be processed;
- ✓ Applicants may be asked for an interview;
- ✓ Additional documents may be required;
- ✓ Applicants from some nationalities may take slightly longer pending a decision from Immigration Office in Mozambique.

For visit visa - If visiting family members or friends you must also submit the following documents:

- The Term of Responsibility (this document must be signed by the host and authenticated by an official Notary, also attach the copy of his/her ID or DIRE).

For business visa - You must also submit the following document:

- A mission letter issued by your organization in France;
- Letter of invitation from the official or business institution in Mozambique, (if travelling for private/official business or volunteer activities).

For a work or residency visa - You must also submit the following documents:

- Copy of the Work permit and employment contract authorized by the competent authorities (e.g. Ministry of Labour or Immigration Office);
- Criminal Record Certificate and Health Check.;
- Term of Responsibility or declaration of your employer;
- Proof of Financial/Maintenance guarantee, if you are applying for a Residence Permit.

For a training or student visa - You must also submit the following document:

- University admission letter or training certificate issued by the company responsible for your training in Mozambique
- The letter of your University in France

For Journalist visa:

- You must contact the “Gabinete de Informação” (Information Office) in Mozambique for authorisation, before applying for a Visa.

VISA FEES AND PAYMENT

The fees charged to apply for the issuance of Visas at the Embassy are as follows:

The applicants must pay all required commission fees for a complete transaction and must attach the bank transfer confirmation made to the Embassy of Mozambique France.

Please Note: **Cash or vouchers are not accepted.**

IMPORTANT INFORMATION:

The Visa application must be submitted 1 or 3 weeks before the date of your expected journey.

Single Entry Visa allows one entry and the length of stay can range from 1 TO 30 DAYS (renewable to a maximum of 90 days, provided that the Visa is still valid at the moment of application).

Multiple Entry Visa allows more than one entry during the validity of the Visa (3 MONTHS). The length allowed for visitors' stay during each entry will be spelt out in the Visa.

POSTAL APPLICATIONS: Applicants who wish to apply for their Visa by post are required to send all the Visa Requirements using registered postal services AND to supply a self-addressed stamped and registered envelope for the return of their passports. **VERY IMPORTANT:** The Consular Section is **NOT LIABLE** for loss or delay of the applications or documents. **YOU MUST ALSO BE IN FRANCE AND JOINEBLE AT THE TIME YOU ARE APPLYING FOR YOUR VISA.**

Please Note: **Work, Residency, Student and Journalist** Visas must be done directly at the Embassy by the applicants.
